6.1 Real Property Acquisition – Discussion

Board president Silvia Vaca stated the school district has the opportunity to purchase a property for use as a District Office and other related needs at 1500 E street, near the elementary school. The property totals 5.0 acres. The acquisition of this property would provide the district the opportunity to own its District Office instead of renting facilities for this purpose. The District would be represented by the Superintendent, Dr. Lampkin, and Director of Fiscal Services & Accountability, Mechele Coombs, and Lisa M. Kaplan, Consultant, Sage Realty Group, Inc.

Jeff Threet stated he has done an initial assessment of the property. There is access to utilities on E Street and Virginia Street. The ADA upgrades that are needed can be done economically.

Board president Vaca stated 5 acres would be a great investment for the district.

Trustee Yareli Mora questioned the cost for the upgrades and what the current rent amount is for the district office.

Director of Fiscal Services & Accountability Mechele Coombs stated the district pays \$4800/month to rent the district office space.

Superintendent Dr. Lampkin stated that is \$57,600/year in rent.

Dr. Lampkin stated this will move us forward in acquiring the property then we will contact the California Department of Education (CDE) to get the greenlight from them.
