#### MINUTES

1.0 <u>CALL TO ORDER</u> – Board president, George W. Simmons, called the Special Board meeting of the Williams Unified School District Board of Trustees to order at <u>5:45 PM</u> on February 25, 2020, in the College & Career Center, located at 260 Eleventh Street, Williams, California. - 5.0 <u>AUDIENCE/VISITORS PUBLIC DISCUSSION</u> Board president, George W. Simmons welcomed all visitors and invited them to speak at this time on any school-related item scheduled on the agenda may do so at this time. Please state your first and last name. Superintendent Dr. Lampkin stated Robert J. Miller & Associates, Inc. has 40 years of grant writing experience. The cost will be \$8,200 quarterly if the agreement is approved prior to March 1. Dr. Lampkin is looking at a school safety grant and secondary pathways grant to help do the work we need to do.

Trustee Yareli Mora questioned if there was any assurance in receiving grant funding.

Director of Fiscal Services & Accountability Mechele Coombs stated there are no guarantees but we will have a dedicated grant writer assigned to our district.

Trustee Mora requested updates for the Board on the progress of grants.
